

- Opened in 1951
- 8.1-acre site
- LAUSD Charter School since 2008
- 674 students enrolled last year
- Enrollment capacity is 652 students
- Enrollment capped in 2010 to respond to an increase in neighborhood enrollment



Project Scope

- Replace ten portables
- Add eight new classrooms
- Reconfigure Admin Bldg.
- Expand lunch shelter
- Increase parking count
- Site improvements
 - Student drop-off area, site utilities, landscaping
 - Furnishing and equipping of new and reconfigured facilities
 - > ADA, DSA, CEQA, DTSC



Project Description COLFAX CHARTER ELEMENTARY Rooted in Education. Reaching for the Stars.



- Allows for 160 new K-5th grade students
- 36,255 sf of new construction
 - New classroom building (16 new classrooms)
 - Kindergarten classrooms (2 new classrooms)
 - Administration building (remodel)
 - New lunch shelter and covered walkways
- 86 Parking Spaces






California Environmental Quality Act (CEQA)

 - > Avoid or minimize environmental damage
- Public Disclosure
 - > Provide an objective document
 - Inform decision maker about environmental consequences
 - > Disclose why decisions were made






- Required Standards
 - > Collaborative for High Performance Schools (CHPS)
 - All LAUSD new school construction projects
 - > LAUSD Standard Conditions of Approval
 - Adopted by BOE in November 2015
 - > Federal, State, Regional, Local Regulations



- All of the potential environmental impacts caused by the project would be reduced to less than significant levels through the incorporation of LAUSD Standard Conditions as mitigation.
- 8 of the 19 environmental topics found Less than Significant or No Impacts.







- CEQA Notice Distribution
 - > Published in Los Angeles Daily News
 - Mailed to ~120 addresses within a 300-foot radius
 - > Emailed to another ~130 interested parties and elected officials


